Experimental evidence on the role of workers' participation in determining work practices is hard to be found. We fill this gap by designing a natural field experiment on the effects of participation and recognition of workers on quality provision. Our framework is novel, as it studies complex tasks performed by permanent employees in an industrial country. Our methodology leverages on the geographical remoteness of three twin facilities of the same firm. In two facilities we exogenously introduce a recognition scheme based on an accurate and continuous record of mistakes. In the first facility (bottom-up treatment), the workers choose the scheme. In the second facility (top-down), the manager introduces the scheme. Our results show that the bottom-up treatment has a significant and persistent positive effect on quality provision with respect to the top-down group. Further evidence suggests that in the top-down group procedural justice concerns and a less favourable attitude towards the management might be the drivers of effort withdrawal and increased mistakes.
